- How is it possible that the Word has conquered Jerusalem, and yet Stephen is stoned? Why does the Lord Jesus, who is looking on, not deliver Stephen?
- What is God's purpose in allowing the church that has just been gathered from the nations in order to be His people to so quickly be scattered again? How does this account lead us to redefine what it means to be *victorious*?
- What do you notice about Stephen's knowledge of the Scriptures from his message? How does that speak to you?

### I. The Accusation (6:10-14)

A. What were the charges?

- i. That Stephen had spoken blasphemy **against Moses and against God**.
- ii. That he speaks against **the Holy Place** (the temple) and **the law**.
  - a) They say he claimed that Jesus would **destroy the temple**.
  - b) That Jesus would **change the customs** handed down to the Jews.
- iii. **speaking blasphemous words...**
- iv. and that they said he **never stopped...**

B. Jesus and the destruction of the temple. (Luke 21)

- i. Luke 21:5-6, 32.
- ii. Luke 21:12-15 with Acts 6:10

## II. Stephen's Defense – Manifesto (7:2-53)

### A. Observations:

### B. Abraham: central to God's election of Israel (7:2-8)

- i. God appeared to Abraham **in Mesopotamia**.
  
- ii. 7 God's promise was about worship, not the temple.

### C. Joseph: Central to God's preservation of Israel (7:9-16)

- i. God was with Joseph in Egypt.
- ii. God used Joseph's being in Egypt to preserve Israel.

### D. Moses: Central to God's deliverance of Israel (7:17-42a)

- i. 17 Israel went from a family to a nation in Egypt.
- ii. Moses was born in Egypt. And raised by an Egyptian. Educated in all the wisdom of the Egyptians.
- iii. 25, 27 Their ancestors, however, did not recognize Moses and rejected Him as ruler, judge and deliverer.
- iv. 29, 30 God appeared to Moses in a burning bush in Midian at Mt. Sinai.
- v. 33 Since God was there that place was Holy Ground.
- vi. 36 God worked salvation, signs and wonders in Egypt, at the Red Sea and in the Wilderness.
- vii. 38 It was in the wilderness that God then gave Moses the law!
- viii. 37 Stephen quotes the law of Moses here, and it points to Jesus!
- ix. 38-39 The law is living words intended to effect our hearts! Unfortunately it did not have that effect in Moses' day or in Stephen's day!
- x. 40-42 Stephen quotes the law regarding idol worship.

### E. The Prophets: Applied God's Truth (7:42b-53)

- i. 42b-43 The Prophets (Amos 5:25-26)
  - a) 1 Kings 8:27
  
  - b) Act 17:24
  
- ii. A moving tabernacle served God just fine. (44-46) God never asked for a house. (47-50)
  
- iii. 51-53 Stephen lumped the unbelieving Jews in with all the nations—idolaters!

## III. The Dispersion Begins... Again (8:1-4)

- i. How does a man who so effectively models the grace of our Lord Jesus, in the process of being a witness, offend the audience so much that they want to kill him?

- iii. If the Word, as I proposed last week, has conquered Jerusalem, why is Stephen stoned? Why does the Lord Jesus, who is looking on, not deliver Stephen?
