LIVE THE STORY

The Gospel is intended to be learned and lived in community. The following questions are designed for use in our Community Groups as an aid to growth in the Gospel and Community.

- In Acts 24, are you left with the impression that this godless Roman leader is significantly more just than the religious leaders of Jerusalem? Explain.
- How might Paul feel when he learns they had a lawyer. How might he have prayed in response?
- Paul put forward his manner of life as a Christian as a benefit to Roman society in our text. Could your manner of life be put forth as testimony in a trial as benefiting to our society?
- Does your Christian faith have such an effect on your life that it could be a point of defense in your favor if falsely accused?
- Do the sin-ridden and self-centered decisions of Felix derail the plans of Christ and His Kingdom for Paul? What does that say to you and me?
- Do the happenings in political elections ever cause you to fear? How might Paul's experience in Acts 24 speak to this?
- What issues do we face today that might make you wonder if the kingdoms of this world have the upper hand on Christ?
- Are there people in power in your life that create anxiety for you? What can we learn from Paul from this text?
