#### Introduction

The reality is that many of us have had to wrestle through problems with authority in our lives

Jesus, as the Divine King, has authority over *everything* and *everyone* 

## I. What Kind of King Rides a Donkey? (vv. 1-11)

A. Finally, Jerusalem

Matthew 16:21

The Jesus who will very shortly be given over to the religious leaders, who will do to him whatever they decide, actually has authority over those religious leaders and over everyone else

B. The first "living parable": Riding a donkey?

Psalm 118:26

One commentator suggests that we should title this scene "The Un-Triumphal Entry"

C. Authority problems

"This is who we're supposed to submit to?"

Romans 1:1-3; Zechariah 9:9 E. "Foolishness" and authority II. Who Gave Jesus Authority to Overturn Tables? (vv. 12-17) A. The second "living parable": Prayer and robbers? B. More authority problems "What gives this guy the right to come in here and stop these transactions?" Isn't this simply an instance of moving products closer to where the consumers need them? C. "Not in my house" It makes sense to allow buying and selling in the temple unless you're the One the temple was built to worship Isaiah 56:7 D. Not only about the temple 1 Corinthians 6:19-20

D. "In accordance with the Scriptures"

The owner of the house has the authority to tell you what the house was built for

## III. Who Gave Jesus Authority to Expect Fruit? (vv. 18-22)

A. The third "living parable": Fig expectations

Somewhat shockingly, Jesus curses the fruitless fig tree and the tree withers at once

B. Still more authority problems

Why use the authority over creation in such a seemingly petty manner in this instance?

C. Not just a fig tree

John 1:3; Matthew 5:6

D. Fruit expectations

Do Jesus' high expectations keep you from submitting to Jesus' authority over your life?

Are there areas of your life you're holding back like the rich young man in Matthew 19?

Galatians 5:22-23; Matthew 21:22
